

**DIXON BOAT AND FISHING CLUB, INC.
APPLICATION FOR USE OF CLUB FACILITIES**

I, _____, do hereby apply for the use of the Dixon Boat Club club house for a family related function. I promise to abide by the Dixon Boat Club by-laws and regulations of the Club. I will use the Club facility for _____, and guarantee that I will:

1. Pay a \$250.00 deposit, of which \$100.00 is a refundable deposit after the event is over and a suitable assessment of the Club facilities is performed. I understand that if this function is catered by the Dixon Boat Club, the cost will be added to the total rental price.
2. I will limit the attendance to 100 persons, not to include the 2 club members which will tend the bar (if applicable), and any uninvited Club members which may wish to use the club facilities during my scheduled event.
3. I will have my event approved by the Dixon Boat Club Board of Directors prior to the event scheduled date. After approval of this event, I will not deviate from these approved plans without written permission of the Board.
4. I will abide by the Port Captain's wishes, as I know he/she will have the final say in matters of dispute.
5. I have acknowledged, and will notify the attendees that the Club usage hours are from 10:00 am to 10:00 pm and that my event is scheduled accordingly. I will also notify my guests that the bar will close one half hour (1/2 hr) prior to my event ending. That would be 9:30 pm if my event was so scheduled. Without exception. No overnight camping privileges are allowed for attendees.
6. I will not allow minors into the bar area for any reason during this scheduled event. The Alcoholic Beverage Control permit forbids the presence of those under the age of 21 from being in a place that serves alcohol and I will not disobey their rules.
7. If the bar is to be used, I will provide for usage by one of two means:
 - A. A closed bar system where the beverage tickets are pre-paid according to the prices set by the Board of Directors.
 - B. An open bar system where the applicant orders a set number of tickets and is charged by the number of tickets collected at the bar.
8. I further realize I will make arrangements for two (2) Club members to tend bar, both of which must be approved by the Board. I have contracted the following members as possible bartenders for the event.
9. I will notify the Club Bar Chairperson of the type of event and any special requirements of the bar for the event, as well as the Kitchen Chairperson if my event is in need of the kitchen. ABC rules do not allow attendees consumption of alcohol not purchased from the Club during this event.
10. I realize that I am solely responsible for clean-up after the event, including the removal of trash from all containers and replacing the trash liners, kitchen and bathroom cleanup, as well as the general Club House facility.
11. I am solely responsible for the Club facilities and my guests during this scheduled function, and I will hold the Dixon Boat and Fishing Club, Inc., the Board of Directors, and its members, harmless for any injury or damage which occurs as a result of this event.
12. I realize that failure to abide by these agreements will result in the immediate termination of

my membership by the Board of Directors and loss of my deposit.

13. I also agree that although this event may be private, I can not prevent usage of the Club facilities, boat ramp, docks, bar, or any other part of the Club facility, by any member or their guests, during my scheduled event.
